



# Application for Membership

## Membership Definitions:

- Annual Single: All membership amenities with unlimited Greens and Cart fees for the designated member.
- Annual Family: All membership amenities with unlimited Greens and Cart fees for the member, spouse and dependent children under the age of 23.
- Seasonal Single: All membership amenities with unlimited Greens and Cart fees for the designated member. Membership is for 6 consecutive months of the member's choice.
- Seasonal Family: All membership amenities with unlimited Greens and Cart fees for member, spouse and dependent children under the age of 23. Membership is for 6 consecutive months of the member's choice.

## MEMBERSHIP AMMENITIES

- Unlimited greens fees
- 14 day advanced tee times
- Preferred tee time
- Participation in member club events
- Men's and Ladies golf association
- Practice balls

1. Acceptance of this application shall entitle the member access to the golf course subject to the following;

The Club retains the right to schedule and host events that may from time to time restrict member access to the golf course. Otherwise members shall be entitled to reserve tee times to play golf, and to play golf without reservations of tee times on an “as available” basis, at any time the golf course is open and available for play, which shall be determined in the sole discretion of the Operator. The Operator shall be responsible for the scheduling of starting times and providing a controlled and orderly operation of the golf course.

2. The member understands and acknowledges that the payment of the fee does not give the member any rights of ownership in the Club or its facilities.
3. The member understands and acknowledges that the Club is operated as a public access golf course and that the rights granted herein do not limit the right of the Operator to offer play at the golf course, or use of the other club facilities, to the general public.
4. The Operator reserves the right to change the price charged for annual and seasonal passes, cart rental fees, green fees, charges for goods and services in the golf shop, and charges for food or beverages at any time.
- 6 All privileges granted to the member shall commence on the effective date of the application.
7. Owner shall have the right to assign this agreement, and the right to collect any amounts owed under this agreement, to any successor operator or owner of the Club.
8. Member understands and acknowledges that the operator retains the right to establish and modify the rules and regulations governing use of the club by members.
9. Member hereby agrees to indemnify and hold the Club, their respective successors, assigns, employees, directors, shareholders, officers, partners, representatives and members, harmless from any and all loss, cost, claim, injury, damage or liability which may be incurred by anyone as a result of the use of the club, including all its facilities, by member, member’s family and guests of member.
10. In the event it shall become necessary to forward member’s account to an attorney for collection and/or legal action to recover any fees or charges incurred on member’s account, or to enforce any provision of this Agreement, including the membership policies, then member agrees to be responsible for all costs of collection, including a reasonable attorneys’ fee.

## **STARTING TIMES**

Members shall be permitted to reserve tee times up to fourteen (14) days in advance on a first call, first reserved basis. Events, tournaments and outings will be scheduled and posted not less than thirty (30) days prior to the event if possible. Members may use the preferred reservation time to schedule a starting time for the member and up to three guests, provided that the Member plays with his guests.

## **TERMINATION**

1. This Membership may be suspended or terminated for the following reasons:
  - (i) Commission of any theft at the facility
  - (ii) Willful destruction of club property, or the property of other members, their family or guests;
  - (iii) Physical or verbal abuse of club staff or other members, their family or guests;
  - (iv) Sufficient cause as determined by the Operator in the best interest of the club.

In the event of a violation the Operator may give the member written notice of such violation and the consequences of the violation. The Member shall have a period of ten (10) days from receipt of notice to request in writing a review hearing before the Operator. If a request for a review hearing is made, Operator shall give notice to the member of the date, time and place of the review hearing, which shall be no longer than thirty (30) days from the date of request by member. The review hearing shall allow the member the full opportunity for explanation. The member may attend the review hearing in person or by representative. The decision of the Operator as to termination or suspension shall be binding and final. The Operator shall give the member written notice of its decision within ten (10) days of the date of the review hearing. Operator shall have the right to suspend the members privileges during the hearing process. During any period of suspension, neither the member nor his family is allowed use of the club.

In the event of termination, the member shall be liable for all fees and charges incurred with the Club and no refund of any part of the initial fee will be made.

The failure of Operator to notice, suspend or terminate member, or any other member of the Club, for any of the above violations shall not constitute a waiver of the right of Operator to give such notice and take such action as may be necessary upon any later violation.
